Our food distribution programs typically target the most vulnerable people living in specific areas, such as orphans and vulnerable children, female-headed households, the elderly, or people with disabilities.

We are looking for a supplier who can provide high-quality food items at competitive prices according to a specified delivery schedule and is able to meet the following requirements:

- Provide evidence of experience in supplying food packs in similar quantities to that requested in this call for tender,
- Package the food items in the packaging provided by IRSA
- Demonstrate the ability to meet the volume and timing requirements of the project
- Demonstrate a commitment to ethical business practices in terms of fair labour practices and pricing, product quality and safety including any certifications or licences and ethical marketing and representation.

- The completed IRSA Ramadan tender document
- A copy of your company registration documents
- A valid SARS Tax-Clearance Certificate confirming VAT registration

- The quote must be comprehensive, i.e. all items as per the list of contents in the food pack must be quoted for. If you do not have the item in stock, please provide an estimated price on the quote.
- The supplier agrees to provide IRSA with additional information or supporting documentation as and when requested. Documents may include proof of delivery capacity, certificates of compliance with food safety standards, letters of good standing from the auditors and the most recent audited financial statements.
- All non-perishable food items must have an expiry date after 14 August 2025 for the Ramadan food hampers and after 17 September 2025 for the Al Fitra food hampers.
- A maximum of two brand names may be provided for each item – a primary brand and an alternate brand.

- All food items on the Al Fitra list must be readily available from 17 March 2025 and packaged by 21 March 2025.
- Food pack contents must be packed in specified Islamic Relief Ramadan packaging, which will be provided by IRSA.
- The quote should indicate the cost per item before VAT, the VAT per item and the cost inclusive of VAT.
- Delivery charges, if any, should be separately indicated in the quotation and not included in the cost per item.
- Packaging costs, if any, should be separately indicated in the quotation and not included in the costs per item.
- The quote should be in South African Rand (ZAR).

Tender Price Validity Period

The Prices of the food items on the quotation must be valid for 60 days from the closing date of tender.
