1. ABOUT ISLAMIC RELIEF

Islamic Relief South Africa (IRSA) is registered as a non-profit company. Its mission is to help the poor and those in need regardless of race, ethnicity or political affiliation, to live sustainable, self-reliant lives within safe and caring communities.

IRSA implements a food pack distribution program that supports vulnerable families during the holy month of Ramadan. The objective of the program is to provide food assistance to people in need, particularly those who are suffering from hunger and malnutrition due to disasters, poverty, or other circumstances. The program is designed to provide people with the nutrients they need to help prevent or mitigate the negative health effects of malnutrition and to enjoy wholesome nutritious meals during the month of Ramadan and the day of Eid ul Fitr.

Our food distribution programs typically target the most vulnerable people living in specific areas, such as orphans and vulnerable children, female-headed households, the elderly, or people with disabilities.

2. CALL FOR TENDER

Islamic Relief South Africa is seeking a reliable supplier to supply Ramadan and Al Fitra food packs to distribute to those in need during the holy month of Ramadan. The food pack quantities and contents are subject to change. The food pack contents are listed in the Pricing Schedule Annexures. The Ramadan food packs are for KwaZulu-Natal, Gauteng, Eastern Cape and the Western Cape. The Al Fitra food packs are for KwaZulu-Natal, Gauteng and the Western Cape.

We are looking for a supplier who can provide high-quality food items at competitive prices according to a specified delivery schedule and is able to meet the following requirements:

- Provide evidence of experience in supplying food packs in similar quantities to that requested in this call for tender,
- Package the food items in the packaging provided by IRSA
- Demonstrate the ability to meet the volume and timing requirements of the project
- Demonstrate a commitment to ethical business practices in terms of fair labour practices and pricing, product quality and safety including any certifications or licences

4. TERMS AND CONDITIONS:

- Quote must be comprehensive, i.e. all items as per the list of contents in the food pack must be quoted for. If you do not have the item in stock, please provide an estimate price on the quote.
- The supplier agrees to provide IRSA with additional information or supporting documentation as and when requested. Documents may include proof of delivery capacity and certificates of compliance with food safety standards.
- All non-perishable food items must have an expiry date after 18 August 2026 for the Ramadan food hampers and after 20 September 2026 for the Al Fitra food hampers.
- Two brand names have been provided for each item – a primary brand and an alternate brand.
- All Ramadan food hampers must be fully packed and completed for inspection by IRSA by 5 February 2026 and must be ready and available for distribution from 9 February 2026.



Drawdowns of the food packs will take place from 9 February 2026 to 13 February 2026.

- All Al Fitra food hampers must be fully packed and completed for inspection by IRSA by 10 March 2026 and must be ready and available for distribution from 12 March 2026. Drawdowns of the food packs will take place from 12 March 2026 to 18 March 2026.
- Food pack contents must be packed in specified Islamic Relief Ramadan packaging, which will be provided by IRSA.
- The quote should clearly indicate the cost per item before VAT, the VAT per item and the cost inclusive of VAT.
- Delivery charges, if any, should be separately indicated in the quotation and not included in the cost per item.
- Packaging costs, if any, should be separately indicated in the quotation and not included in the costs per item.
- Quote should be in South African Rand (ZAR).
- Adequate and secure storage capacity for completed food packs for a minimum of one week is required to support phased daily drawdowns by IRSA representatives for distribution within selected regions in the province.
- IRSA representatives will, upon reasonable prior notice, conduct audits of completed food packs to verify expiry dates, product condition, approved brands, item weights, quantities, and completeness of contents.

5. Tender Price Validity Period

The Prices of the food items on the quotation must be valid for a period of 90 days from closing date of tender. Due to market volatility, prices for identified perishable items and selected high-volatility commodities may be subject to review and adjustment, subject to written motivation, supporting market evidence, and prior written approval by Islamic Relief South Africa (IRSA). No price adjustments will be permitted without IRSA's written approval.

6. Evaluation Criteria

Bids will be evaluated in accordance with Islamic Relief South Africa's procurement policies, based on:

- Submission of all mandatory documents and completed Annexures;
- Demonstrated capacity and experience to supply, package, and deliver the required food packs within specified timelines;
- Compliance with food pack specifications, quality, expiry date, food safety, and Halaal requirements;
- Competitive and complete pricing in line with the pricing schedules;
- Adherence to ethical business practices and IRSA's zero-tolerance approach to fraud and corruption.
- Non-compliant bids may be disqualified.

7. Reservation of Rights

Islamic Relief South Africa (IRSA) reserves the right, at its sole discretion and without incurring any liability, to:



- Cancel the bid process at any stage prior to award;
- Withdraw this tender in whole or in part;
- Amend, vary, or adjust the scope of the tender, including but not limited to changes in quantities required;
- Substitute, add, or remove product brands and/or specifications based on operational requirements, availability, or organizational needs;
- Reject any or all bids received, whether in whole or in part.

Bidders shall have no claim against IRSA for any costs, losses, or damages incurred as a result of such cancellation, withdrawal, amendments, or changes.
